ORDER OF CONTEMPT

On April 10th 2019 this court ORDERED the Respondents to reinstate all APPS of the Petitioners and all accounts as well as remove various RELIGIOUS HATE DOCUMENTS from public search response results for the name SOLLOG.

Upon Affidavit filed in this matter the court has become aware that the Respondents have not complied with their COURT ORDER.

The respondents were given PUBLIC NOTICE of the ORDER in their Public Twitter Account for Respondent Sundar Pichai.

The Clerk of this court emailed notice of the COURT ORDER to various emails for the legal department and the key executives named in this matter.

It is the Courts Opinion that the Respondents have intentionally DEFIED THIS COURTS ORDER and for that reason this Court is finding the Respondents in CONTEMPT OF THIS COURT.

THE COURT FINDS AND ORDERS:

1. Based upon Affidavits and a check of the Google Play Store for the Petitioners Apps the Court finds that all of the Respondents in

this matter are IN CONTEMPT OF THIS COURT for not obeying this Courts Order of April 10th 2019.

2. The COURT ORDERED if the Respondents ignored this Courts Order that a FINE of \$1 BILLION US DOLLARS would be levied upon the Respondents if they failed to OBEY THIS COURTS ORDER by April 11th 2019 at 8:00 AM EST.

3. This Court finds each Respondent IN CONTEMPT OF COURT and FINES EACH RESPONDENT \$1 BILLION US DOLLARS INDIVIDUALLY and Payable immediately to the clerk of this court.

4. The Court warns the Respondents that every day at 8:00 AM EST this court will find the Respondents are still in CONTEMPT and this Court will FINE ALL RESPONDENTS \$1 BILLION US DOLLARS DAILY at 8:00 AM EST for every day they are not in compliance of THIS COURTS ORDER date April 10th 2019.

5. The Respondents must immediately comply to this Courts Order dated April 10th 2019.

6. The Respondents must immediately pay the Clerk of this Court \$1 BILLION US DOLLARS EACH and if they wish to appeal

this finding of Contempt, they must still pay the Clerk of this Court the fines levied upon them.

7. After 7 Days this ORDER is a FINAL ORDER as the Court views it pursuant to the rules of this Court and this finding cannot be appealed after April 18th 2019.
