EMERGENCY TEMPORARY RESTRAINING ORDER

Ex Parte

In a Emergency Temporary Restraining Order Ex Parte matter before the court filed by the Hon. Dr. Rabbi Sol Adoni on his behalf and also on behalf of a The Adoni Trust, Adoni Publishing and 1 MEDIA, 247 News, 1 SEARCH, 1 Lawyers, 1 Doctor versus Respondents Google and ABC Company (A Public Company) and Sundar Pichai CEO Google, Sergey Brin and Larry Page founders of Google the Court finds:

The Petitioner the Hon. Dr. Sol Adoni is a Member of the Nation of ONE and is therefore entitled to bring actions in this court.

The Petitioner did file with the court an Emergency Temporary Restraining Order Ex Parte against the Respondents and the court has duly considered said Motion and based upon an affidavit and copies of emails from Respondent Google filed in the Petitioners Emergency TRO Ex Parte the court agrees the court has the Jurisdiction to make this Emergency Temporary Restraining ORDER Ex Parte.

THE COURT ORDERS:

1. Respondent Google is to IMMEDIATELY reinstate all accounts of the Petitioners including the Android Developer

Publishing account of Adoni Publishing controlled via email address adonipub@gmail.com.

2. Respondent Google is to immediately remove Petitioners from any type of “black list” they are on which keeps the Trademarks and websites of the Petitioners from showing in Google ‘SERPS’ for their famous trademarks which include;

247 News

1 eBooks

1 Search

1 Lawyers

1 Doctor

All domains registered to the Domain Name Trust which is being targeted by Google in regards to not showing websites operated by the Petitioners prominently in searches for their brand name trademarks. A simple review of other search engines such as Bing and Yahoo show these names, many of which which existed since the 1990’s, are well known international trade marks of the

Petitioners and the exclusion of them in 'SERPS' by respondents is an obvious attempt to black list them.

3. Google is hereby ORDERED to remove immediately from their SERPS for the name SOLLOG, the religious name of Dr. Adoni, the following derogatory web pages this court deems to be religious harassment of Dr. Adoni. The court notes most of the pages are almost 15 years old and irrelevant to searches for SOLLOG who has many mentions in major media. It is obvious to this court that SOLLOG SERPS are being manipulated by respondents to harass and defame Dr. Adoni over his religious beliefs.

4. The court warns the respondents that should they not do exactly as ordered by this court by April 11th 2019 8:00 AM they will

be held immediately in contempt of this court and fined the sum of One Billion US DOLLARS (\$1,000,000,000 USD) per day for every day they do not obey this court and reinstate the Android Developer Publishing Account of the Petitioners and remove the aforementioned articles from SERPS for SOLLOG and remove any and all black lists for Trademarks of the Petitioners including 247 News, 1 eBooks, 1 Search, 1 Lawyers and 1 Doctor and all other trademarks owned by the Petitioners and used with websites for international business purposes.

5. This court ORDERS the immediate actions of the respondents to comply to this ORDER and the respondents may motion this court within 7 days to not make this TRO a PERMANENT ORDER for any legal arguments the respondents wish the court to consider.
